I/We are applying to participate in the **Fifth Annual Peaches to the Beaches Yard Sale** from Culloden, GA to the Golden Isles of Georgia, **March 13-14, 2009**. I/We understand that I/We must submit a participation fee of **\$30.00 per space needed**. (12' deep X 10' wide) or **\$180 for our offsite group location with 6 or more vendors** with this application to be considered for a space. I/We understand that the participation fee is being split between the local Convention and Visitors Bureau and The Golden Isles Parkway Association (the group originating, overseeing and promoting all official yard sale sites along US Highway 341). **Make check payable to: "GIPA Peaches to Beaches."** I/we understand that the event will take place rain or shine, and that there will be no refunds.

I/We further agree to hold harmless the organizations, their officials and all event volunteers overseeing this event if an injury is sustained, accident occurs, or damage/theft of property occurs during participation in this event by me or any member/volunteer of our organization.

I/WE FURTHER UNDERSTAND THAT THIS IS A "FAMILY-FRIENDLY" EVENT and that I/We agree that no objectionable messages/symbols on clothing items or signage, explicit objects or paraphernalia will be displayed or offered for sale in the space during this event. I/We further agree that any yard sale official may inspect what is being offered for sale in the space at any time and I/We will remove or cover up any items deemed by the official to be objectionable items, which detract from the "family-friendly" nature of this event.

I/We understand that no clothing or other items bearing the official PEACHES TO THE BEACHES YARD SALE logo are to be produced or sold at this event.

In **Perry, Georgia**, it is understood that official group vendor site for the PEACHES TO THE BEACHES YARD SALE will be located at: The New Perry Hotel and adjacent parking lots. Set up sites at this location are limited and will be on a first come, first serve basis OR I/we understand that I may select my own private property site along Hwy 341 and be listed as an official vendor.

I/We understand that if the site we are assigned to is consolidated with another site or moved, we will be notified and given the opportunity to select another site. **(PLEASE NOTE: If your organization has a structure along US 341 and you have sufficient parking around that structure, you may be allowed to have your official yard sale at your site if it meets the public safety requirement for parking and ingress and egress. Please ask when applying if you have an interest in this.)**

MOVE-IN DETAILS for on site vendors. It is understood that I/We may begin to move items into the designated space **AFTER HAVING RECEIVED MY CONFIRMATION FROM THE GROUP ORGANIZERS AND LOCATED MY ASSIGNED SPACE(S) MARKED WITH MY LAST NAME on Thursday, March 12th AFTER 1PM.** I/We understand that security of the items in the space allocated to me or my organization is not the responsibility of the organizers or volunteers of this event. I/We understand and agree that I/we may not have a motorized vehicle in the sale area after 7:30 AM on the days of the sale until after the sale is over each day, however, I/we understand that we may purchase an additional 10x12 space in which to park our vehicle during the event. **(Advertised hours of the Yard Sale are Friday and Saturday 8 AM to 6 PM.)** I/We also understand that no electricity will be provided to any space by the organizers. I/We understand that every effort will be made by sale officials to allow large items to be taken by me to a designated loading area during the sale for pickup by purchasers. This loading area will be at the edge of the sale area and available to all vendors on a first-come, first-served basis. I/We agree to park my/our vehicle(s) in any legal public parking space outside the event area.

ONSITE VENDORS AT THE OFFICIAL GROUP SITE WILL BE NOTIFIED OF YOUR LOCATION UPON ARRIVAL TO THE VENUE. Applicants must have submitted the application and provided the necessary funds to be on the list for space allocation. If there are spaces available the day before the sale, they will be made available on an “as available” where designated basis. There will probably not be the opportunity to get an additional space adjacent to your existing space at the last minute, **SO THINK BIG AND GET AN EXTRA SPACE WHEN YOU FIRST APPLY.** ON-SITE REGISTRATION WILL BE OFFERED ON A SPACE-AVAILABLE BASIS.

THE MAIN EVENT SITE WILL HAVE A COORDINATOR WHO WILL BE YOUR CONTACT BEFORE AND DURING THE SALE. You will be contacted well before the event with details as they are developed.

Because this will be an annual event, **YOUR PARTICIPATION IN THIS YEAR’S EVENT WILL GIVE YOU THE RIGHT OF FIRST REFUSAL TO PARTICIPATE IN NEXT YEAR’S EVENT.** It is anticipated that this event will grow over the years and will be successful for all who want to participate. **THANKS FOR YOUR INTEREST IN PARTICIPATING IN THE FOURTH ANNUAL PEACHES TO THE BEACHES YARD SALE, MARCH 13-14, 2009!**
